1	A receipt with applicant's username (Etudes en France, Campus France online file No., ex. IR15-00027)	
2	The application form , filled completely in French or English and signed and dated by the applicant.	
3	Two color photos , not older than 6 months, with a white background and in 3.5 x 4.5 cm, covered by 70% to 80% of the applicant's face, <u>without any hair covering</u> .	
3	Passport: Valid for at least three months after the expiry date of the requested visa, with at least 2 unsealed pages and must be signed by the bearer. The copy of the Identity page and the copies of all Schengen visas (on the current and previous passports) and the copies of all entry and exit stamps.	
4	Shenasnameh (Birth certificate) , officially translated in French, with copy of all pages	
5	Military Service Completion Card, officially translated in French. Dates of the military service shall be included on the card.	
6	Education certificates , translated in French and legalized by the French Embassy, if applicable. Employment and leave certificate , translated in French, if applicable	
7	Supporting documents for the financial ability. The applicant needs to prove he/she can afford 615 euros per month for the first academic year. • If the applicant is on scholarship , the certificate for covering the costs by the respective organization. • If the applicant has a guarantor , ID proof of the guarantor, cost bearing certificate , along with the supporting employment documents and the last three months of the original bank account circulation statements with stamp (personal account and professional account, in Latin), recent tax payment receipt, applicant's relationship certificate with the guarantor (if the guarantor lives in France). Applicant's employment and leave certificate, if applicable. The guarantor shall be applicant's close relatives in Iran or France (Father, mother, brother, sister, grandfather, grandmother, uncle, or aunt) • If the applicant does not have a guarantor , the supporting employment documents and the last three months of the original bank account circulation statements with stamp, personal account and professional account, in Latin.	
8	Accommodation certificate in France: Certificate by the admitting institute or organization (ex. Crous or certificate of accommodation), a copy of lease agreement or title deed, French national I.D. card or residency permit of the host in France.
